- 2. The first voucher sold will be 100% donated and any additional 4 person dove vouchers sold will be split 50/50. The NPO will receive an invoice via email once we receive the buyer contact information.
- 3. There is an obligation of a minimum winning bid of \$1500

1. Voucher will be valid for 3 years from the auction event.

- 4. The formal voucher/certificate will be sent to the person(s) who purchases the trip by email along with all important initial information within 5 days of receiving buyers contact information. The recipient's information should be forwarded to the Pointer Wingshooting email address below.
- 5. The person that purchased the voucher can give it away. Additionally, the buyers may extend the "use by date" up to 24 months by paying an extra \$1000 USD to Pointer Wingshooting.
- 6. The buyer will be able to customize the trip to a different lodge or to include duck/perdiz/pigeon hunting, or golden trout fly fishing for an additional cost to the buyer.
- 7. To make the voucher valid there must be a minimum of 4 hunters. Less than 4 will incur a \$650 fee to validate the voucher.

- 8. Force Majeure- Should events occur that are beyond the control of Pointer Outfitters, such as acts of God, war, serious illness, threats and/or acts of terrorism, civil disturbances, inclement weather, flight cancellations, flight delays, denied entry into the country, lost luggage and equipment, Pointer Outfitters is not liable.
- 9. Pointer Outfitters will be able to relocate the buyer to another lodge by Force Majeure reasons should events occur that are beyond the control of Pointer Outfitters.-

## Responsibilities to use the 100% donated Argentina dove hunt

- 1. The non-profit has the obligation to inform the buyer about all terms and conditions the day of the event and prior to the auction item, through communicating inclusions and exclusions best achieved by printing the Hunt Description in the auction booklet. The non-profit organization will not be allowed to re-write information on behalf of Pointer Outfitters.
- 2. The nonprofit organization and the key point-of-contact person that signs below will be the only responsible party should complaints arise from the buyers regarding confusion about the voucher information.
- 3. Event coordinator is responsible to send the auction winners name, email, and phone number, and the amount paid for the voucher to <a href="mailto:stacey@pointeroutfitters.com">stacey@pointeroutfitters.com</a> within 5 business days after the auction.
- 4. It is our preference that multiple hunts be sold. If there are multiple hunt vouchers sold, the 2<sup>nd</sup>, 3<sup>rd</sup> and others, will be at a 50/50 split with Pointer Wingshooting. You will receive an invoice with payment instructions. Funds will be sent to a Pointer Account within 20 days of the event. Bird Dog Travel, local US LLC representing PW interest, will accept a check, a Frost Bank direct deposit or a wire transfer.
- 5. The auctioneer and non-profit key point of contact recognizes, knows and accepts all info about the voucher and the hunting conditions.
- 6. The auctioneer and non-profit recognizes, knows and accepts that Pointer Wingshooting could mention the nonprofit's name and partnership with PWS in fundraising, in their media and/or publications.
