A South Dakota style pheasant hunt in the Texas Panhandle for 5 individuals in January 2025.

Pheasant hunts are conducted just 15 minutes north of Lubbock, Texas in CRP fields, native pasture, tree rows and lake bottoms. Hunts typically begin at daybreak (7:00 am) and last until lunch (12:00 pm.) However, we will guide until your party is wholly satisfied with their experience. Breakfast burritos will be provided the morning of, along with water and cokes, however, we accommodate BYOB if your party wishes to do so with prior notice. There is no



bag limit for pheasants as the acreage is registered as an Upland Game Bird Preserve, and the
pheasant population is supplemented with farm-raised birds. We hunt with German Shorthaired
Pointers to point, flush & retrieve birds. We recommend that your party brings 12 or 20 ga.
shotguns, plenty of shells (6 shot), warm clothes and common sense. We look forward to guiding your hunt, please contact for booking and more information, I can be reached by cell (806) 777 – 6802 or email at wyattjharlan@gmail.com.
