

How Resale Will Work For 2020

For buyers wishing to purchase and choose the "resale" disposition option we are aware the exact resale credit amount on your bill will not be determined until the animal is weighed, which will be after you make your purchase.

Below are estimated resale amounts based on current market prices. The announced resale prices for the sale will be available on stockshowauctions.com as well as the Merced County Fair website starting June 11th.

Beef:

Weight Range 1,000 - 1,300 lbs Estimated Resale = \$1,020 - \$1,326

Goat:

Weight Range 60 - 105 lbs Estimated Resale = \$162 - \$283

Sheep:

Weight Range 100 - 150 lbs Estimated Resale = \$80 - \$120

Swine:

Weight Range 200 - 265 lbs Estimated Resale = \$100 - \$132

RULES APPLYING TO THE JUNIOR LIVESTOCK AUCTION

- 1. Bump Bids will be allowed. Bids will be on a separate form for each buyer and bump bids must be flat fee or price per pound.
- 2. It shall be expressly understood that the Merced County Fair (35th District Agricultural Association) acts only as an agent for the consignees and assumes no liability, legal or otherwise.
- 3. Responsibility for livestock sold remains with the exhibitor until delivered to the Merced County Fairgrounds on June 17th. Thereafter, responsibility will rest with the transportation company for safe delivery.
- 4. Animals exhibited at the Merced County Fair, meeting the following specifications, may be sold:

Beef, Sheep and Goats Market Ready
Swine Market Acceptable

5. For sale purposes, payment will be made on maximum weights as follows:

Beef 1,300 pounds
Swine 265 pounds
Sheep 150 pounds
Goats 105 pounds

- 6. No animals purchased through the Junior Livestock Auction may be resold in the auction, returned or given back to the exhibitor by the buyer.
- 7. No animal sold through a Junior Livestock Auction may be purchased and sold through another fair's Junior Livestock Auction.
- 8. Live pick-ups must be paid in full prior to leaving the fairgrounds and must be picked up on Wednesday June 17th. Call the livestock office at 209-722-1421 to arrange pickup.

FINANCIAL RESPONSIBILITY OF BUYER

All payments for livestock are to be made to the Merced County Fair. Accounts not paid within 30 days will be considered delinquent. A finance charge of 1½% per month, which is 18% annually, will be charged to all accounts over 30 days. Collection of amounts outstanding for **45 days** will be handled by the Empire Collections. Accounts turned over to the Empire will have interest plus a \$20 processing fee added to the total balance due. For collection purposes, individual(s) signing sale invoice and/or proxy form will be responsible for payment.

If the animal goes for resale, the buyer will be charged the difference between the bid price and the market price posted the day of sale. If the animal goes for custom slaughter, the buyer will be billed for the full price bid.

Custom cutting, wrapping and freezing charges are paid directly to the locker by the buyer. Offal becomes property of the processor.

Individuals/companies with outstanding balances from previous auctions will not be permitted to purchase animals. In addition, buyers with outstanding balances as of September 30, 2019 will not be permitted to purchase at the 2020 auction.

MOST FREQUENTLY ASKED QUESTIONS

Why not????, they do it at Chowchilla or Los Banos Fairs!

As I like to say, "Fairs are all the same but different". Yes, we all have an annual fair, however there are actually three types of fairs, Fair/Festival, State and County. We are fortunate to have all three types in close proximity.

- Chowchilla is a Fair/Festival. They have nine (9) board members from within their community.
- Los Banos Spring Fair is a Merced County Agency and is governed by the County of Merced. They have fifteen (15) Fair Board members appointed to the Fair Board by the Merced County Board of Supervisors.
- Merced County Fair (35th District Agricultural Association) is a State Agency and governed by the State of California. There are nine (9) members on the Fair Board who are appointed by the Governor.

We are all subject to State Rules, however, there are also local rules set by the Board of Directors at each fair.

If an animal is purchased, what can I do with it?







<u>Process</u> <u>Live Pickup</u>

Have custom killed and fill your freezer. Pick up live. Payment in full required prior to release of animal.

Resale



Have the animal automatically resold to a meat packer at market price and pay only the difference. How the resale works:

If you buy a 120 pound lamb for: \$3.00 a pound Sale Price \$360.00 Approximate Market Value \$.82 a pound Market Value - \$96.00 Your donation Billed amount \$264.00

The donation amount is what you would be billed. Figure the beef, hog and goat the same way. Market prices will be posted the day of the auction.

How much is the commission withheld from the Exhibitor's checks?

On all auction bids as well as bump bids a 5.5% commission on beef, 7% on Dairy Heifer Replacements, 3.5% on Rabbits and 6.5% on hogs, sheep and goats will be deducted from all sale checks. For the 2020 sale, the Friends of the Fair are graciously donating all of the commission as 100% of the sales will go to the exhibitors.

What is the auction commission held from the Exhibitor's checks used for?

In the CDFA, Division of Fair & Exposition's Accounting Procedures Manual it states "The Auction Reserve account is the accumulate total of operations, that is, the net revenue from yearly auctions. The Board should specify minimum and maximum balances for this account. The minimum balance should be sufficient to cover bad debts and other unforeseen expenses. When the Auction Reserve exceeds its maximum, the board and the JLA committee should develop a mutually agreed-upon plan to reduce the amount of the reserve by reducing the amount of commission to be withheld, or spending excess reserved on capital improvement to benefit the livestock program". Our Auction Committee and Board of Directors have chosen to use those reserves on capital improvements to benefit the livestock program. Below is a listing of items purchased over the last four years from the auction contingency funds.

These are just a few of the items totaling \$158,672. Fortunately, the committee had the foresight to save up those funds over the years knowing that a good amount would be spent on the livestock pens and cooling fans once the Hilmar Cheese Barn was completed.

I'm a buyer and came to purchase animals, why don't I just get in free?

The JLA Auction Committee recommended to the board of directors "sending <u>one</u> admission pass to each buyer who purchased an animal at the prior year's auction." The Merced County Fair (35th DAA) is a State Agency and cannot gift public funds. We simply are not allowed to give free passes unless there is an exchange of services. Buyer's admission passes are charged to the auction contingency fund, the same fund that the exhibitor's commission is deposited into. The Committee is very conservative with these funds in order to spend those funds on improvements that the Livestock Exhibitors can enjoy and receive benefit from. In short, when a buyer brings a friend and/or spouse who pay admission to get into the fair, this as well supports the livestock program.

How are you able to provide Exhibitors their checks so soon after the auction, unlike other fairs? The Merced County Fair takes out a short-term loan through Rabobank for \$550,000. Those funds are deposited into our Auction checking account the week of the fair. The fair is charged \$1,000 for loan processing fee and interest of approximately \$2,500 per month. We are fortunate enough to have buyers who quickly pay their auction bill and generally have the loan paid off within 60 days. In total it costs approximately \$6,000 in loan fees and interest. Again, this is something that is directly related to the Auction so we charge the fees and interest to the Auction contingency fund. Other fairs may do things differently, in that they wait until the buyers have paid for the animals then they send the Exhibitors their checks.

How do I make recommendations to the Junior Livestock Auction or the Livestock Committee? Send a letter to the fair and put "Attention JLA Committee or Livestock Committee." Your correspondence will be reviewed during their annual meetings for consideration and recommendation to the Board of Directors.
